2019 MYSTATE STUDENT FILM FESTIVAL REGISTER YOUR SCHOOL COMPETITION TERMS AND CONDITIONS

2. The “Register Your School” competition (competition) is a promotion to encourage eligible participants to register their school as entrants into the 2019 MyState Student Film Festival.
3. The competition prize is a Rode Rodelink Filmmaker Kit - Digital Wireless System for Filmmakers valued at \$429.00.

CONDITIONS

4. The competition is open to registered schools in Australia who confirm their participation in the 2019 MyState Student Film Festival.
5. Confirming participation is to commit to entering a film submission by the Festival competition closing date (Sunday 27th October 2019).
6. An entrant’s participation in the 2019 MyState Student Film Festival is the submission of a film entry.
7. Entries for the Register Your School competition can be made by principals, teachers and educators registered by the Tasmania Department of Education, Independent Schools Tasmania or Australian equivalent.
8. Entry to the Register Your School competition is made by completing the online registration form on the MyState Student Film Festival website www.mystatefilmfestival.com.au
9. Consent from all participants within any film has been provided by either the individual or by the individuals parent/guardian. We will review all films prior to submission to make sure that all participants consent has been granted.
10. The Register Your School competition opens on Wednesday 1st May 2019 and closes on Monday 22nd July 2019 (competition period).
11. Entry into the Competition is deemed to be acceptance of these terms and conditions.
12. All entries to the Competition may be subject to verification by Promoter.
13. Any entries not completed in accordance with the rules and conditions or received after the closing time and date of the competition will not be considered.
14. The Promoter will not be responsible for any delayed, lost or misdirected mail or any other communication. Subject to application laws, if either:
 - An entrant cannot be contacted or located to be informed that they are the winner before 30th July 2019;

- The Prize is forfeited for any reason or deemed forfeited by Promoter; or
- Any Prize winner is deemed by The Promoter to be ineligible.

15. 22. MyState will not provide payment to any entrant for the public or private screening of films entered into the competition.

23. MyState does not receive payment from the organisers of public events where competition entries may be screened.

PRIZE AND DRAW DETAILS

24. There will be one prize drawn following the conclusion of the competition period. The winner will be drawn randomly from all eligible entries on Monday 22nd July 2019 and will be notified by telephone.

25. The prize is a Rode Rodelink Filmmaker Kit - Digital Wireless System for Filmmakers includes a receiver, transmitter and broadcast-grade lavalier microphone.

26. Maximum total prize value is \$429.00.

27. If a prize (or part of a prize) is unavailable for any reason, The Promoter will, in its absolute discretion, substitute alternative goods or services of no lesser retail value and/or specification. 36. The prize recipient is responsible for registering the product warranty. This is not the responsibility of The Promoter.

If for any reason The Promoter determines in good faith and its sole discretion that this Promotion is not capable of running as planned due to any event beyond the control of The Promoter, which might corrupt the administration, security, integrity or proper conduct of the Promotion or which may change the intended result or prevent or hinder its determination, The Promoter may in its absolute discretion, to the fullest extent permitted by law, modify, suspend, terminate or cancel the Promotion.
